Performance drivers are the top-down beta positioning as well as bottom-up issuer selection. The fund invests at least two-thirds of its total assets in non-government bonds (which may include contingent convertible bonds (also "coco" bonds)) and similar non-government fixed income securities and asset backed securities from all around the world. The fund will not invest into assets with a rating lower than "B-" by at least one of the recognized rating agencies. The fund takes into account the contribution of a company to the United Nations Sustainable Development Goals (SDG). The portfolio is built on the basis of the eligible investment universe and an internally developed SDG framework for mapping and measuring SDG contributions, about which more information can be obtained via the website www.robeco.com/si. Performance

Based on transaction prices, the fund's return was 0.59%.

The Bloomberg Global Aggregate Corporate Bond Index gained 0.41% in October (hedged to EUR). US IG spreads widened by 5 bps, while EUR IG spreads tightened by 2 bps, to 78 and 76 basis points respectively. Government yields moved lower: the 10-year Treasury declined by 7 bps to 4.08%, and the 10-year Bund by 8 bps to 2.63%. Total returns were driven mainly by falling sovereign yields, while credit excess returns were slightly negative for the month. The portfolio performed broadly in line with its benchmark before fees. The impact from beta was negligible, as we maintained a near neutral stance throughout the month. Issuer selection added meaningfully to performance, with EUR investment grade significantly outperforming US investment grade, so most of the selection effect came from our regional allocation. This was largely offset by a negative contribution from duration, currency and other noncredit factors

Market development

Markets stayed firm in October as an extended US China trade truce, solid data and decent earnings supported risk assets. Early tariff threats from President Trump sparked a risk-off move, but later meetings with President Xi delivered a renewed truce and scaled back measures. Equities finished higher, with the S&P 500 up 2.3 percent for a sixth consecutive monthly gain and Japanese stocks rallying after Sanae Takaichi became prime minister. Rates rallied alongside risk. The Fed cut its policy rate by 25 bps in late October but signalled that another December move was not assured, leaving the 10-year Treasury yield at 4.08 percent, its lowest close in over a year. The ECB and Bank of Japan left policy unchanged. Credit markets were resilient. Concerns around private credit and regional banks weighed on financials, but fundamentals and inflows kept global spreads broadly stable. Toward month-end, heavy hyperscaler jumbo issuance added pressure on credit spreads, particularly in the US. Precious metals extended their rally, with gold moving above 4,000 dollars per ounce and silver posting a sixth consecutive monthly gain.

Expectation of fund manager

Credit markets remain comfortably numb: spreads hover near cycle tights and risk appetite holds even as growth slows and inflation risks persist. Strong technicals and fading memories of drawdowns keep investors long, yet valuations leave no margin for error. In the US, credit defies weakening fundamentals: softer labor demand, margin pressure, and political interference at the Fed risk reigniting inflation into a cooling economy. Tariff pass-through and sticky services prices lift stagflation risk, so complacency is the enemy. We stay defensive, favoring shorter spread duration and higher quality issuers. Europe remains our preferred region given sturdier balance sheets, near target inflation, and supportive technicals. In IG, we keep spread duration short, underweight in long dated USD, and tilt up in quality. In HY, we run roughly neutral beta in BB and B, avoid CCC, and hunt idiosyncratic carry. We take profits in European corporate hybrids after sharp tightening, and stay overweight in European bank subs. EM technicals are constructive, but stretched valuations argue for selection over beta. Bottom line: we are cautious on valuations, constructive on technicals, and patient on adding risk

Sector allocation

In our portfolio management, we not only factor in weights, but also spreads and durations (DTS). On that basis, we are overweight in financials and underweight in non-financial corporates. Within financials, we are overweight in the banking sector. We hold an underweight position in corporate risk, primarily due to our stance on energy and utilities. Conversely, we are overweight in consumer cyclicals, as auto manufacturers and suppliers, affected by recent profit warnings, have underperformed and now present attractive valuations. Some of the sector underweights can be attributed to negative SDG scores.

Sustainability

Sustainability is incorporated in the investment process by the means of a target universe, exclusions, ESG integration, and a minimum allocation to ESG-labeled bonds. The fund solely invests in credits issued by companies with a positive or neutral impact on the SDGs. The impact of issuers on the SDGs is determined by applying Robeco's internally developed three-step SDG Framework. The outcome is a quantified contribution expressed as an SDG score, considering both the contribution to the SDGs (positive, neutral or negative) and the extent of this contribution (high, medium or low). In addition, the fund does not invest in credit issuers that are in breach of international norms or where activities have been deemed detrimental to society following Robeco's exclusion policy. ESG factors are integrated in the bottom-up security analysis to assess the impact of financially material ESG risk on the issuer's fundamental credit quality. Furthermore, the fund invests at least 10% in green, social, sustainable, and/or sustainability-linked bonds. Lastly, where a credit issuer is flagged for breaching international standards in the ongoing monitoring, the issuer will become subject to exclusion.



SDG Impact Alignment

This distribution across SDG scores shows the portfolio weight allocated to companies with a positive, negative and neutral impact alignment with the Sustainable Development Goals (SDG) based on Robeco's SDG Framework. The framework utilizes a three-step approach to assess a company's impact alignment with the relevant SDGs and assign a total SDG score. The score ranges from positive to negative impact alignment with levels from high, medium or low impact alignment. This results in a 7-step scale from -3 to +3. For comparison, index figures are provided alongside that of the portfolio. Only holdings mapped as corporates are included in the figures.



Sustainalytics ESG Risk Rating

The Portfolio Sustainalytics ESG Risk Rating chart displays the portfolio's ESG Risk Rating. This is calculated by multiplying each portfolio component's Sustainalytics ESG Risk Rating by its respective portfolio weight. Environmental Footprint


Environmental footprint expresses the total resource consumption of the portfolio per mUSD invested. Each assessed company's footprint is calculated by normalizing resources consumed by the company's enterprise value including cash (EVIC). We aggregate these figures to portfolio level using a weighted average, multiplying each assessed portfolio constituent's footprint by its respective position weight. For comparison, index footprints are shown besides that of the portfolio. The equivalent factors that are used for comparison between the portfolio and index represent European averages and are based on third-party sources combined with own estimates. As such, the figures presented are intended for illustrative purposes and are purely an indication. Only holdings mapped as corporates are included in the figures.

Engagement


Robeco distinguishes between three types of engagement. Value Engagement focuses on long-term issues that are financially material and/or are causing adverse sustainability impacts. The themes can be broken into Environmental, Social, Governance, or Voting-related. SDG Engagement aims to drive a clear and measurable improvement in a company's SDG contribution. Enhanced engagement is triggered by misconduct and focuses on companies severely breaching internationals standards. The report is based on all companies in the portfolio for which engagement activities have taken place during the past 12 months. Note that companies may be under engagement in multiple categories simultaneously. While the total portfolio exposure excludes double counting, it may not equal the sum of individual category exposures.
